

# Domestic Electricity Safety Check & Improvement Grant Scheme

## Guidance Notes



### **Aim.**

The grant scheme provides financial assistance for occupied residential properties to have their existing, domestic electricity installation improved, tested and certified by a qualified electrician, without the owner having to incur the full costs.

### **Eligibility.**

Owners including landlords of occupied residential properties over 5 years old or static caravans of any age are eligible for this scheme.

Financial assistance for the extension of an existing safe system or the installation of a system in a new property are not eligible under this scheme.

Materials must be locally purchased and must be to British standard. Decorative fittings are not eligible.

Survey and final test must be completed by a locally registered, qualified electrician. All work must be up to standards of the current Electrical Regulation (17th Edition).

The scheme does not extend to cover portable or fixed electrical appliances, fire alarms, heating controls and TV aerials, or similar.

After a successful grant application a period of 5 years must lapse before reapplying for the same property.

### **Grant Assistance.**

A grant of 100% is available for covering the cost of an electrical safety check.

A grant of up to 75% is available for covering the costs of new materials, to a maximum of £750.

A grant of up to 25% is available for covering the costs of skilled labour, to a maximum of £200. Skilled labour is defined as a person with relevant qualification or who actively works towards the relevant qualification (ie an apprentice).

Materials limited to the basic installation include; consumer unit, sockets, cable, light sockets, switches, backing plates, junction boxes, sleeving, mini-trunking and fixings.
